## Public Works

- Chuck Mack reported that he attended a meeting with the Fire Department to discuss the flow data and to purchase Storz Snozzles for the fire hydrants. A total of 66 are needed totaling \$15,745.00, the breakdown would be approximately \$235.00 per hydrant, He spoke with Clerk Treasurer Ebert and she said that we could pay it out of the LIT Public Safety Fund and the installation would be done by the Public Works department. Motion by Councilman Cook; Second by Councilman Oehmen to approve the purchase of the Storz Snozzles.
- The Public Works department would begin their hydrant flushing starting Monday May 6<sup>th</sup> to go through May 10<sup>th</sup>.
- Chuck Mack reported that he got several quotes for the roof replacement on the REMC building. He would like to have Gluth Brothers perform the work for approximately \$55,648.00 with the knowledge that it could cost more if there was additional damage underneath the existing roof that they can't visually see as of now. He spoke to Clerk Treasurer Ebert and they agreed to use the remaining funds from the ARP for this purchase. Motion by Councilman Cook; Second by Councilman Mayo to have Gluth Brothers perform the work and to have the remaining ARP funds pay for this work.
