- Park Board President Newburn reported that they will meet in December.
- Animal Control Officer Spears reported that resident Deborah Reed called and said that
 her cat was stuck in the crawl space of her house. No action was needed as the cat came
 out the next day. He also reported that Stephanie Durham called about a cat under her
 car. She called the LaPorte County Police because Bryan was out of town. No officer
 ever came and resident never let Bryan know if the problem was resolved.
- Building Commissioner Fred Matuszak reported 1 Driveway, 1 Contractor Registration, 1 Accessory Building and 1 Peddlers Permit totaling \$245.00. President Newburn enforced the fact that if someone comes to your door selling construction, new windows, etc., to make sure the first thing you ask is for their Peddlers Permit. It is a requirement of the town.

Clerk's Office Reports

- Personnel Committee –No Report
- Facilities Coordinator Clerk Treasurer Ebert reported that she had completed the lease agreements for 2025 and everyone was up to date on their insurance for their rental property.
- NIRPC –Clerk Treasurer Ebert reported that she had attended the Executive Board meeting held on October 17th, 2024
- Other –Clerk Treasurer Ebert asked the Council if they reviewed the Walking List she
 provided via email regarding possible replacement for Councilman LaFoone. No
 response was given, but she asked if they could revisit that so that position would be
 filled by the end of the year.
 - o She also reported that she needed guidance with Indiana Farm Bureau regarding the accident at the REMC building. The estimates received to fix the building was so much lower than what Tonn & Blank was estimating to fix it. Councilman Mayo and Higgins stated that they would send me additional contacts for construction bids to see if they would be comparable to what we already have.

Public Works

Chuck Jonas reported that on November 17th & 18th they will be shutting off approximately 35 residents on Earl Street so they can replace hydrants. Jonas said that the resident would be without water for approximately 2 hours and would have to boil water for about 2 days before drinking it. He also reported that they will be doing some Tree Trimming in the town along with the Striping for the roads.

- Motion by Councilman Mayo; Second by Councilman Higgins to approve to prepay Holiefield Pest Control for a 5% discount.

- Motion by Councilman Higgins; Second by Councilman Mayo to move forward with the rezoning of the Smokers Property.
- The first reading of Ordinance 06-2024 Wastewater Rates was given by Clerk Treasurer Ebert. Roll Call was given; All Ayes. Discussion was held on the two options given, one being an increase for 19.5% and the other to be for a 25% increase. The option for a 25% increase was advertised in the local newspaper. The consensus was to lean towards the higher increase but the approval for which option the Council would vote on would be at the December 5th, 2024 meeting.
