- President Newburn was given a report from Councilman Higgins to read at this 12/5/24 meeting.
 - O President Newburn reported that regarding the complaint of speeding over on Condon Road that was brought up at the November 7th, 2024 meeting, Councilman Higgins spoke to Prosecutor Shawn Fagan about getting 4 flashing digital signs for the Town. Two of those signs would be for Condon Rd. and the remaining 2 can be decided by the Council.

O President Newburn also reported that Councilman Higgins has been working on securing a grant with MCR Partners to put towards our Wastewater project. Councilman Higgins also asked the Council to approve the request in the amount of \$500,000 dollars of ARPA Grant money pending its availability and legal counsel with our attorney. Motion by Councilman Sutton; Second by Councilman Mayo to approve that request of \$500,000 dollars of ARPA grant money to be put towards our Wastewater project.

Public Comment

- A lengthy discussion was held regarding the Pro-Pel 30 project. Scott Sandstrom was the representative for Pro-Pel 30. Many disagreements from residents Greg & Debbie Smoker, Jeff Mitzner and several others about the options given from Pro-Pel 30 that would disrupt our town as a whole. Businesses would be ruined, having little access to get to a burning building, and properties destroyed. Rep. Sandstrom encouraged us all to meet the December 13th, 2024 deadline and send a comment of all our grievances to Indot. Due to only having 8 days to do that, Sandstrom was asked to reach out to Indot for more time on our behalf. He said he would do that and send an email to CT Ebert when he received confirmation. Councilman Howell said that he would take the lead on producing these statements after Attorney Shoffner approved it. Resident Jeff Mitzner said he would write the statement on behalf of the Cass-Clinton Fire Department.
- Kevin Ferrell went before the Council to ask them to rezone the church located on 208 N Illinois. Discussion was had about all the steps Mr. Ferrell would have to take. Councilman Howell encouraged him to attend the February 27th, 2025 Planning Commission meeting so they could begin this process.
